End of Life Type: **Description:** In an effort to maximize manufacturing efficiency for Micron's SLC NAND Flash memory product line, and to better align with industry trends, Micron will be discontinuing production over the coming years of Small Page SLC NAND Flash devices produced in its Fab-13 Singapore facility. This discontinuance action will allow Micron to better focus efforts on supporting 34 and 25nm SLC NAND Flash products. The Small Page SLC NAND Flash products contained in this notification provide a Last Time Buy in March 2018, and a Last Time Ship date in June 2021. Micron recommends order placement well in advance of the last-time buy date in order to align availability of product. Micron is taking these actions to better focus efforts on supporting 34 and 25nm SLC NAND Flash products that deliver the most value to our customers, and we encourage customers to consider using one of Micron's 1Gb SLC NAND Flash products as a replacement to Small Page NAND for any new application or design.
